*Allows ANY prodigy to grandfather into BRIF program for \$150 fee until Sept 1, 2010 WE WILL BEGIN ADVERTISING YOUR STALLION AND ACCEPTING PRODIGY NOMINATION AS SOON AS YOUR PAPERWORK AND PAYMENT ARE RECEIVED.

*After Sept 1, 2010 prodigy may enter into program at the following rate

Weanlings - \$150 (paid for life) (due by Dec 1 weanling year)

Two Year Old - \$250 (paid for life) (due by Dec 1 of Two Year Old Year)

Three Year Old - \$350 (paid for life) (due by Dec 1 of Three Year Old Year)

Four & Over - \$500 (paid for life)

*Stallion listed on website and in BRIF stallion ads

*Stallion himself may enroll in BRIF program (even if his sire is not a nominated stallion) for an additional fee of \$150 (lifetime)

*Stallion owner will receive an annual accounting of all nominated stallions and nominated prodigy by Jan 1

*Stallion owners will be asked for feedback on BRIF program on an annual basis

*No refunds for any reason (except in case of #3 in rules page)
