

## Thank you for your nomination to the Hawki Futurity!

Please review our check list of items and return at check in. Check in is Friday from 1-3 pm in the MPA arena, and again Sat from 8-9 am in the MPA. You need to bring your hoses registration papers (coggins if from out of state) to check in.

If you plan to carry over your horses futurity time from the open Sat/Sun your deadline to enter without late fee and designate carry over is check in. Once your horses is checked in you cannot make additions/changes to the open entry. If you do not pre enter the Barrel Ba\$h you may late enter at the event on your futurity horse without a late fee (for Sat/Sun only processing fee does apply).

NOTE- we do not take checks for entry fees at the event (unless you are a WPRA member with a current card). On-site entries are cash only.

If you have other horses you are entering in the Barrel Ba\$h those entries are due (postmarked) Sept 24.

Additional stalls should be paid for with your final futurity payment OR your Barrel Ba\$h entry so that we can have all your horses stalled together.

We will have several awards at this year's event! There are no additional fees – please read the descriptions below and mark which incentives your entry is eligible for. Incentives will be POSTED outside show office after all horses are checked in. Please double check the list to make sure we have you listed in the correct incentive.

\_\_\_\_\_ **IOWA OWNED/BRED/RIDER (\$500 bonus)** (horse must have been bred in Iowa, Currently Owned by Iowa Resident, Ridden in futurity by Iowa Resident)

\_\_\_\_\_ **4 YEAR OLD INCENTIVE** (futurity horses 4 years old and under as of Jan 1, 2010)

\_\_\_\_\_ **Rookie Rider** (very first year of futurity competition – never entered any other futurity or futurity sidepot before 2010 futurity competition year)

\_\_\_\_\_ **Amateur Rider** (lifetime earnings of \$1000 or less and rider has never had a WPRA card OR permit at any time – amateur rider MUST own horse – horse must be in rider's name (on papers)

\_\_\_\_\_ **HFBI** – horse sired by HFBI stallion (if stallion is not currently paid up but has been paid since entry was foaled you may pay additional \$100 fee to be eligible for this \$10,000 bonus)

Rider/owner please sign and date....By making entry I verify that this horse has not competed in barrel racing prior to Dec 1, 2009. I understand that my winnings/awards/titles will be revoked if horse is found to have entered prior to this time, and rider/owner will not be allowed to participate in BB Productions, LLC futurity event in the future. (please sign and date)
